

# Patient, Public, Involvement and Engagement Lead (PPIE) NIHR ARC North Thames

#### Context

Applications are invited for this exciting opportunity to lead the public and community involvement, engagement and participation (PPIE) activities of the National Institute for Health Research (NIHR) Applied Research Collaboration (ARC) North Thames. This is an excellent opportunity for an experienced involvement lead to ensure that patients, the community and the wider public are at the forefront of the work of NIHR ARC North Thames.

The post holder will have knowledge of the health and care sector, and an understanding of involvement and engagement methodologies and national standards. The role is closely aligned with the PPIE function of our partner organisation UCLPartners, whose PPIE colleagues will provide ongoing support and mentorship to the role holder. The role holder will also collaborate with involvement and engagement colleagues from the ARC host NHS Trust (Barts Health NHS Trust), UCL and other ARC partner organisations.

Candidates should have experience of facilitating the involvement and engagement of patients and members of the public in research, and be an effective communicator who is proactive and efficient at working with a wide range of individuals and organisations.

This full time post (part time will be considered) is available until 30 September 2024, in the first instance.

#### **NIHR ARC North Thames**

NIHR ARC North Thames is a partnership of over 60 organisations from across North Central and North East London, Essex, Hertfordshire and Bedfordshire. These organisations include leading universities, the NHS, councils, patients, communities, charities and industry who share a commitment to improving health and social care services, and people's health.

Working together, we identify the key health and care problems facing organisations in our partnership, design innovative research in response and rapidly put findings into practice across our region and beyond.

The ARC Director is Professor Rosalind Raine, Head of Department of Applied Health Research at UCL Institute of Epidemiology and Health Care (https://www.ucl.ac.uk/epidemiology-health-care/).

### Main purpose of the job

- The role is key to the strategic and operational work of the ARC and offers an exciting opportunity to work with senior leaders in research and healthcare and with patients and the public in an energetic and dynamic working environment.
- The post holder will be responsible for operational delivery of the ARC's PPIE strategy and implementation of ARC PPIE activities. An important element of the ARC PPIE strategy is the involvement of communities in our work.
- The post holder will lead PPIE in a new ARC Mental Health research capacity and capability programme in East London and Essex.
- The post holder will work closely with other NIHR ARC North Thames staff and with experts in PPIE throughout the partnership to ensure a coherent approach and to maximise opportunities for involving the public in our research.

### **Duties and responsibilities**

- Lead ARC PPIE activities; promote and support high quality PPIE initiatives and opportunities across the ARC to ensure patient, public and community voice is at forefront of research.
- Deliver and implement the ARC North Thames PPIE strategy.
- Conduct and report on patient and public involvement within ongoing research projects (including preparing annual reports for the funder), and develop and lead PPIE for new studies. Develop effective systems to capture the impacts of PPIE across the ARC and share best practice.
- Lead PPIE on ARC Mental Health research capacity and capability building programme in East London



- and Essex; facilitate co-production of the programme with patients and members of the public.
- Plan, organise, expand and support the ARC PPIE panels of public contributors, including:
  - o Actively recruiting new members by promotion of our research through professional and social media, meetings and patient and public research awareness activities.
  - o Actively engaging with, and providing support and guidance to current and potential members and providing training.
  - o Designing and enhancing generic and study specific PPIE documents in collaboration with other representatives.
  - o Organising and delivering regular PPIE panel meetings, liaising with panel members and researchers, and facilitating feedback between the panels and study teams. Facilitating access to the virtual document review panel.
- Develop strategies and opportunities to increase involvement of communities in our work.
- Facilitate involvement of people and communities from wide variety of backgrounds, reflecting diversity of our region. Ensure involvement opportunities widely accessible to people with diverse needs.
- Collaborate with public contributors to support design and delivery of training on PPIE for ARC staff, student and front-line NHS and Public Health professionals as part of ARC North Thames Academy. Provide teaching on topics related to PPIE as requested.
- Create cost estimates for PPIE action plans, advise on reward and recognition for public contributors in line with best practice, process expenses, forecast and review budget expenditure.
- Remain up-to-date on national and international approaches to involvement and engagement, and best practice. Ensure alignment with UK Standards for Public Involvement.
- Build working relationships with PPIE teams across the North Thames region. Explore opportunities for cross-PPIE working, including with ARCs nationally, and represent ARC North Thames on the ARC PPIE Leads Network. Liaise with relevant national PPIE organisations.
- Provide expert PPIE advice to ARC North Thames colleagues at all levels of seniority and contribute PPIE information for grant funding applications.
- Handle sensitive information, and communicate in a sensitive way to patients, carers and members of the public.
- Manage own workload effectively through project and time management skills.

The role-holder will be based at UCL however, due to the nature of the ARC, which involves six London universities and partner organisations, they will be required to travel to other sites.

#### Other:

- The post holder will carry out any other duties as are within the scope, spirit and purpose of the job as requested by the line manager or ARC Director.
- To maintain own continuing professional development as appropriate.
- To maintain awareness of, and engage in, the UCL Communities of Practice appropriate to the role (<a href="https://www.ucl.ac.uk/transforming-our-professional-services/tops-projects/communities-practice">https://www.ucl.ac.uk/transforming-our-professional-services/tops-projects/communities-practice</a>);
- To actively follow UCL policies, including Equal Opportunities policies.
